The Awards Process

1. Find Your Category

Browse 47 diverse award categories to find the best award category for the health care program, service, tool, or solution your patients, clients, or employees utilize.

2. Prepare & Submit Your Entry

Each application should address the mission of the Health Value Awards: recognizing outstanding, outcome-driven, high-quality health care. Download a sample application from our website so you can prepare the best entry possible.

3. Quality Committee & Peer Review

Every application is reviewed by our Quality Committee which ensures the completeness of the application and that the entry upholds the mission of the Health Value Awards. Peer-Reviewed Category applicants undergo an additional review via our panel of data scientists who verify program performance/results claims by digging into the data sets and methods of measurement.

4. Finalists Announced

Award finalists will be notified via email on January, 2020. Being a finalist means you've made the shortlist for receiving an award and that your application will be handed off to our panel of judges. Finalists receive a badge graphic noting this achievement that can be used on social media and websites. Finalists are also listed in our press release.

5. Judges Determine Winners

Our panel of judges is comprised of in-field practitioners and distinguished industry experts. Judges are assigned categories most relevant to their areas of expertise.

6. Announce & Celebrate Winners at the Health Value Awards Ceremony

Winners will be announced live at the 2020 Health Value Awards ceremony hosted by Validation Institute on Sunday, March 29 at World Health Care Congress in Washington, D.C.
