Method / Calculation / Examples

Claims for 90 patients were analyzed for the year 2022. The amount billed for the covered services was gathered, as well as the plan's Allowed Amount, and the amount paid under Renalogic's ImpactProtect program. The services included are listed below.

- Kidney dialysis.
- Lab tests ordered by the nephrologist through the dialysis provider or renal laboratory.
- Drugs and vaccines given at dialysis center or during home treatment such as Venofer, Heparin, or Epoetin.
- Supplies used during dialysis procedures (gauze, syringes, etc.)

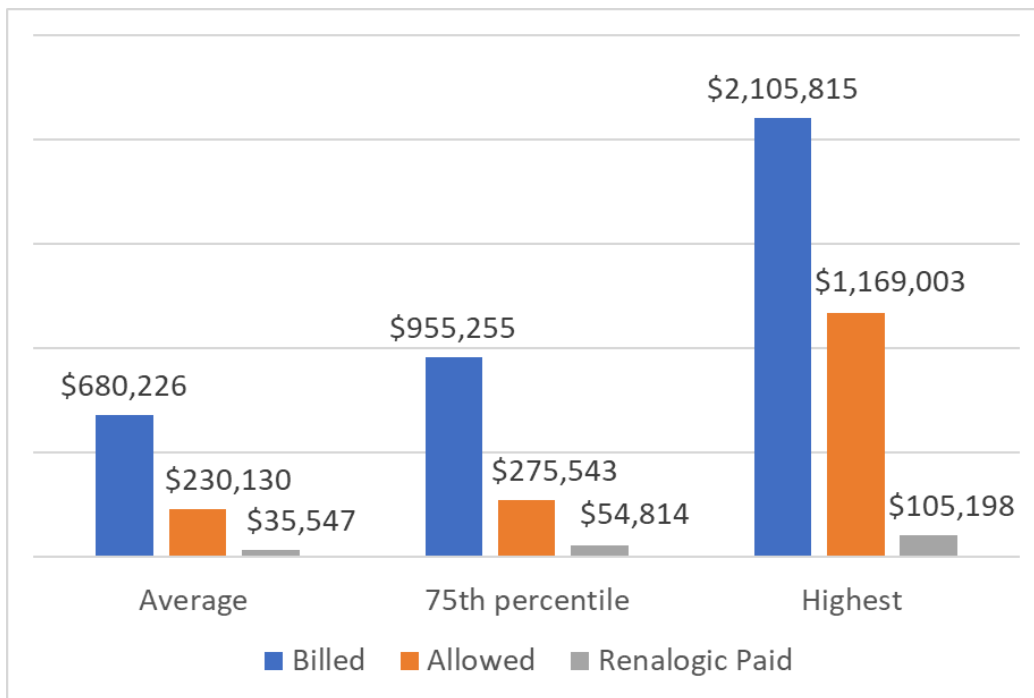
The average amount billed, allowed, and paid per patient was calculated as well as the 75th percentile and maximum. This was to show the range of costs that a kidney patient could have, and the savings the Renalogic ImpactProtect program delivers.





Findings & Validation

The graph below summarizes the average, 75th percentile, and maximum dollars paid per patient for the services included in the package. On average, Renalogic’s ImpactProtect program paid 84.5% less than the plan otherwise would have paid under its Allowed Amount. For the 90 patients included in the analysis, Renalogic’s ImpactProtect program reduced the plan’s 12-month costs by \$17.5 million.





Limitations

A plan that has Allowed Amounts closer to Renalogic's contracted pricing would have lower savings on average.
