Crovetti Orthopaedics and Sports Medicine (COSM) has been providing orthopedic care in the Las Vegas valley for more than 20 years. Its Founder, **Dr. Mike Crovetti** is a Board-Certified Orthopedic Surgeon and treats orthopedic problems in the hip, knee and shoulder.






Claim Assertion for Validation

Crovetti Orthopedics hip or knee replacement patients have fewer hospital admissions (hospital care after surgery) than patients receiving the same services at hospitals. In addition, Crovetti bundles its services to include pre- and post-op care; its price for the service package is 62% to 110% of Medicare's Comprehensive Joint Replacement Average Standard Target Price (excellent, good, and acceptable quality) bundled payment for major joint replacement with complications or without complications.

On average employers pay 143% to 264% of Medicare rates for medical services. (Lopez, Neuman, Jacobson, & Levitt, 2020) Thus, for the majority of employers, Crovetti's prices are lower than what they are otherwise paying.

Method / Calculation / Examples

Crovetti's rate of hospital readmission was calculated by counting knee and hip patients (separately), and then counting the number of patients who had a hospital admission for a condition/complication related to the surgery within 90 days post-discharge. The rate's numerator is the number of patients with admissions; the denominator is the total count of patients.

Crovetti's hospital readmission rate was then compared to Ambulatory Surgery Center and Hospital Inpatient rates from published literature (Carey & al, 2020). The 90-day readmission rate is bellwether quality indicator because adverse outcomes—such as infection, persistent pain, blood clots, and loosening—generally require a readmission.

Crovetti's bundle of services was compared to Medicare's Comprehensive Joint Replacement (CJR) service bundle (Innovation Models - Comprehensive Joint Replacement, 2019). After determining that the services matched, Crovetti's published rate for knee and hip replacement services was compared to Medicare's 2019 Comprehensive Joint Replacement (CJR) bundle rates (Innovation Models - Comprehensive Joint Replacement, 2019). Medicare's CJR has multiple rates for each surgery depending upon the provider's quality and other factors; therefore, an average of the Standard Target Price for excellent, good, and acceptable quality rates was used.





Findings & Validation

Crovetti Orthopedics performed 2,310 knee replacement surgeries, of which 22 required a hospital readmission within 90 days for an illness or complication related to the surgery. This creates a readmission rate of 0.95%. From the literature, the rate of hospital readmissions for knee replacement patients who had their surgery in a hospital was 9.87%; the rate for patients who used an ambulatory surgery center (ASC) was 3.15%. The hospital readmission rate for ASC knee replacement patients was three times Crovetti's rate, and for patients at hospitals, nearly 10 times Crovetti's rate.

Crovetti had 1,254 hip replacement surgeries, of which 17 patients had a hospital readmission within 90 days. The rate was 1.36%. From the literature, the rate of hospital readmission for hip replacement patients who received their surgery in a hospital was 7.69%; for patients in an ASC, the rate was 1.61%. Hospital readmission rates for ambulatory surgery center hip replacement patients was 16% higher than Crovetti's; and for patients at hospitals, more than 5 times higher than Crovetti's rate.

Limitations

This analysis did not measure Crovetti patients' characteristics, which may make them less (or more) likely to have a hospital readmission than a typical patient.
