# Method / Calculation / Examples

---

A randomly selected group of 5,831 employees' use of Emergency Department services was tracked for 2019, 2020, and the first six months of 2021. The number of ED visits per 1,000 member months was calculated for each time period. The year-to-year trend was then compared to a market trend taken from published literature.



# Findings & Validation

---

Chart 1 summarizes the Emergency Department visits per 1,000 members for 2019, 2020, and six months of 2021. The Crucialist practice showed an 11.3% decrease in ER/1000 from 2019 to 2020 and an additional 12.3% decrease from 2020 to the first six months of 2021.

Chart 1: Comparison of ER/1000, Year-Over-Year Reduction, and Total

Year	ER/1000	Annual Reduction	Total Reduction
2019	195.3	-	-
2020	173.2	11.3%	11.3%
2021	151.9	12.3%	<b>22.2%</b>

Chart 2 compares the 2019 to 2020 Crucialist reduction to the Market Trend Reduction from the COVID-19 pandemic. Due to the pandemic, ED visits decreased by 8.1% from 2019 to 2020 (Hartnett, Kathleen P; & et al, 2020). Crucialist results were superior to the COVID Market Trend. Crucialist ER/1000 reduction was 39.9% higher than the Market Trend.

Chart 2: Comparison of Crucialist ER Reduction to COVID market trend

Period	Crucialist ER/1000 Reduction	COVID Market Trend ER/1000 Reduction	Crucialist Outperformed
2019 - 2020	22.1	15.8	<b>39.9%</b>

# Limitations

---

As with any observational study, we cannot know what might have happened without the intervention. Randomly selecting members within a group is meant to strengthen the results. The analyzed group's trend outperforming the market trend indicates a difference.
